### 3. DECLARATION OF THE TRUST AND ITS OBJECTIVES:

The Trustees hereby declare that they and the survivor or survivors of them or other Trustees or Trustees here for the time being will hold the said sum of Rs. 51,000/- (Rupees fifty one thousand) only made over by the Settler to the Trustees as aforesaid and all gifts contributions, subscriptions, donations, request and other moneys or properties as and when the same shall be paid to or invested in them and the moneys, investments and for profit in the territories of India, or for charitable purpose which tends to promote International Welfare in which India is interested and for such purpose (without restricting the generality of the foregoing objects) to do all or any of the following :

- (i) To help, aid, assist, undertake, organise, establish and maintain schools, institutions, colleges for imparting general, vocational, industrial, technical, physical, mental, arts, science and health and assist and provide financial assistance to the poor and needy people of the society and for any other causes of general public utility.
- (ii) To undertake projects, programmes and schemes relating to education such as Medical Institutions, Dental Institutions, Pharmacy Institution, Educational Institution, Hospitals, Charitable Dispensaries, Medical Aid Centres, Clinics, Home for Women and Childred, Maternity Homes, Nursing Homes, Child Welfare Centres, Sanitoriums and other Institutions of similar nature, and to run, maintain vocational training institution for all or any or them.
- (iii) To do all acts, deeds to provide for sanitary facilities and promotion of preventive and other measure for the health of people.
- (iv) To establish, run and maintain Dharmshalas, Rest Houses, Poor Houses or any other such charitable institutions for the benefits of all classes at any suitable place of places.

- (v) To aid, assist and help deserving people particularly in the rural areas in connection with their personal, social and other needs including health, educations, marriages and others.
- (vi) To found, assist and support, establish and maintain libraries and reading rooms and to establish and maintain boarding houses or hostels or assist such institutions.
- (vii) To public books and magazines for the development of education and upliftment of humanity and to distribute them to the public with or without charging price.
- (viii) To provide for endowments, stipends, scholarships and other allowances to deserving and needy students for promotion and encouragement of all types of education.
- (ix) To open and maintain orphanes, widows homes and homes for blind and handicapped persons and provide them vocational and other training or to render assistance to any such existing institution and institutions.
- (x) To maintain, contribute to give aid to any medical educational or social institutions or any charitable institutions with philanthropic purposes which may be in the general interest of the poor of all castes and creed and do all such acts and things with the objects of giving relief to the poor.
- (xi) To do all such acts and things as may be conducive to the general well being of the society and upliftment of the social, educational, cultural or economic conditions of the masses.
- (xii) To conduct training programmes for farmers in the field of agriculture and rural development.
- (xiii) To undertake, implement/execute and put in action the welfare charitable schemes of Central Government/State Government/Local Bodies or any other institutions/agencies for the benefit of the Trust. To implement different programmes of the government such as Jawahar Rojgar Yojana (JRY), Integrated Rural Development Programme (IRDP), Development of Women & Children in Rural Areas

(xxii) To establish charitable health centres for the welfare of poor and needy people. For this purpose, Allpathic, Ayurvedic, Unani, Homoeopathic, Naturopathy system will be adopted.

(xxiii) To provide information regarding Leprosy, Cancer, AIDS and other infectious disease in urban and rural areas, and to render free medical facilities and guidance to the general people.

(xxiv) To train the educated women and youth by providing knowledge of cooking art, learning or house decoration, Health Care & Tourism, Fashion Designing and Gardening.

(xxv) To cultivate the spirit of culture among the people by holding music, drama, dance, concerts, debate, lectures and quiz for the entertainment of the people.

(xxvi) To engage for preparation of statutory report for any industry, creating water and air pollution problem and submit the exhaustive report for preparation of treatment as and when required under the pollution control act prevailing in the different states and the Government of India.

(xxvii) To undertake construction and maintenance of drinking water supply schemes, hand tubewells and drill tubewells in urban and rural areas.

(xxviii) To undertake construction of low-cost houses for the poor in villages and towns. To construct public buildings in urban and rural areas.

(xxix) To construct/reconstruct irrigational channels, canals, tanks wells, along and ahar for public use.

(xxx) To provide legal aid and family counselling services to the general people.

(xxxi) To establish a consumer's education and publication centre for making the general public aware about the consumer's rights.

(xxxii) To establish coaching centres for students preparing for competitive examination.
